**RECOMMENDATION**


THAT the Board of the Peace River Regional District give three readings and adopt "Clearview Arena Artificial Ice Specified Area Establishment and Loan Authorization Amendment Bylaw No. 1881, 2010".

**BACKGROUND**

The Clearview Arena function is at its maximum requisition and the costs are continuously rising.

The Ministry has advised to assist functions that have reached their maximum requisitions there is an ability to raise 5% per year, up to a maximum of 25% for 5 years to assist with the increasing costs, without requiring the vote of the electors. This was put in place due to the fact that when many of the requisitions were established the costs of operations were much less than they are now.

By-law No. 1881, 2010**

A by-law to amend "Clearview Arena Artificial Ice Specified Area Establishment and Loan Authorization By-law No. 598, 1988".

WHEREAS the Regional Board of the Peace River Regional District, pursuant to the Ministry of Community Services Circular No. 07.15, dated June 11, 2007, may increase the requisition limit of a by-law, provided the maximum amount that may be requisitioned for a service does not increase by more than 25% over a five year period;

AND WHEREAS pursuant to Section 801.5(2) of the Local Government Act the Electoral Area Director has agreed, in writing, to the adoption of this amending by-law;

NOW THEREFORE the Board of the Peace River Regional District, in open meeting assembled, enacts as follows:

1. Section 2, Page 2 of the "Clearview Arena Artificial Ice Specified Area Establishment and Loan Authorization By-law No. 598, 1988" is hereby amended by deleting the amount of \$121,000 and replacing it with \$151,250.
2. This By-law may be cited as "Clearview Arena Artificial Ice Specified Area Establishment and Loan Authorization Amendment By-law No. 1881, 2010."
