Re: Kelly Lake Sewer Amendment By-law

Recommendation

that "Kelly Lake Sewage Local Service Area Establishment Amendment By-law No. 1885, 2010" be given three readings and adoption.

Rationale:

The Kelly Lake sewer function is at its maximum requisition and costs are continuously rising. The current requisition is insufficient to meet the annual sewer system operating expense. Further, the requisition has not seen an increase in 10 years.

The Ministry of Community Services and Rural Development has advised that to assist functions that have reached their maximum requisitions there is an ability to raise 5% per year, up to a maximum of 25% for 5 years to assist with increasing costs, without requiring a vote of the electors. This was put in place due to the fact that when many of the requisitions were established the costs of operations were much lower than they are now. The current maximum requisition is \$15,000, if approved the maximum requisition shall be \$18,750 or an increase of 25%.

A by-law to amend "Kelly Lake Sewage Local Service Area Establishment By-law No. 1066, 1996."

WHEREAS the Regional Board of the Peace River Regional District has adopted "Kelly Lake Sewage Local Service Area Establishment By-law No. 1066, 1996;"

WHEREAS the Regional Board of the Peace River Regional District, pursuant to the Ministry of Community Services Circular No. 07.15, dated June 11, 2007, may increase the requisition limit of a by-law, provided the maximum amount that may be requisitioned for a service does not increase by more than 25% over a five year period;

AND WHEREAS pursuant to Section 801.5(2) of the Local Government Act the Electoral Area Director has agreed, in writing, to the adoption of this amending by-law;

NOW THEREFORE the Regional Board of the Peace River Regional District, in open meeting assembled, enacts as follows:

1. Section 5, Page 2 of "Kelly Lake Sewage Local Service Area Establishment Amendment By-law No. 1320, 2000" is hereby amended by deleting the amount of \$15,000 and replacing it with \$18,750.
2. This By-law may be cited as "Kelly Lake Sewage Local Service Area Establishment Amendment By-law No. 1885, 2010."
