Subject: Joint Northern RHD Fall Meeting – Capital Plan

The Joint Northern Health Regional Hospital District meeting was held on Monday, October 18th, 2010 in Prince George.

Attached for information purposes is Northern Health's presentation titled "Update on Proposed Project and Equipment". This report is the proposed projects that are anticipated in the next 10 years. Still to be finalized is funding for the projects and the year in which each project will be started. Note that the list of projects greater than \$5M is missing the Dawson Creek Patient Care Unit Replacement in the amount of \$22,000,000.

Also attached for information purposes is a summary of the proposed projects applicable to the Northeast region only. The total is \$39,999,000 making the PRRHD's 40% contribution \$15,999,600. Note that this list included the Dawson Creek Patient Care Unit Replacement omitted from Northern Health's list.

The specific projects being requested for next year's budget will be made available in the next month to enable the preparation of the Provisional Budget prior to year end. The final list of proposed projects for next year will be presented to the Board by Northern Health prior to preparation of the Annual Budget in March 2011.
