- Capital funding commitments, where Regional Hospital Districts are partnering projecting 3 - 5 years out - to provide better planning.

3. Imbalance of taxation between BC and Alberta

We wish to reaffirm the need for a level playing field between BC and Alberta. The Regional District supports the cities of Dawson Creek and Fort St. John with the information they are bringing forward in this regard.

The inventory of key sites along the Alaska Highway within the Peace River Regional District is expected to be completed by the end of March. Currently Northern BC Tourism Association is conducting consultations with stakeholders, which is one of the steps required in the nomination process. Parks Canada has been very supportive of this initiative.

The delegates went on to say that commemoration of the highway is expected to increase travellers' length of stay in the region and lead to improvements to the highway's historical features. Ultimately it could help to improve the quality of life for residents along the highway. They thanked the directors of the Regional Board for their vision in bringing this project about.
