Colleen Borodula representing concerned residents from the Tupper area handed out a list of "Facts and Figures" as well as a map, relating to the Secure Energy Service's proposal to construct a hazardous waste landfill in the Swan Lake area. She compared the proponent's statements with her research and elaborated on the comments she felt, were conflicting. She highlighted the opposition expressed in the previous night's public information meeting, stating residents feel the risk to the area's ground water sources is too high. They understand there is a need for this kind of disposal service for industry, and that there would be no problem if it were located in another area away from people and water sources.

Mr. Nick Parsons introduced himself as a former dairy and custom farmer originally from England, who now is opposing the potential loss of the agriculturally productive Peace River valley to the Site C Dam project. He equated the beauty of the river valley with three scenic rivers in New Zealand and stated that there is less than one percent of soil in Canada that has this type of highly productive microclimate. He agreed that dams could be successfully built on canyons and rock valleys, but not on sloughing hills, which the Peace is noted for. He said he couldn't understand why BC Hydro refused the bid for power, and essentially shut down the proposed Thunder Mountain wind project, which had the potential to produce power equal to Site C, without the destruction of prime agricultural land along the valley. He also felt there were other existing dams in the province which could accommodate more turbines and produce power closer to where it is consumed, reducing the amount of line loss waste which occurs in the transmission power from the north of the province.

Mr. Parsons elaborated on the upcoming fifth annual "Paddle for the Peace" event which is being held to bring awareness to the valley that would be lost forever, should Site C proceed. His hope was that in twenty years, the boating event could celebrate twenty-five years of enjoyment of the scenic river valley.

Mr. Parsons read a letter he received from Premier Gordon Campbell in July of 2009, recognizing his concerns.

In closing, Mr. Parsons stated that the future of the river is in the peoples' hands.
