10) D-1 Michelle LaBoucane, Coordinator explained the philosophy of the North Peace Justice
North Peace Justice Society which delivers its service through the community forum method, where a safe
Society controlled environment is provided for offenders and victims to come together under the
Michelle LaBoucane, guidance of a trained facilitator to find different solutions to the offence, rather than
Coordinator going through the expensive court system. Over the past seven years, three hundred
re: Introduction to the and fifty cases were referred to the restorative justice program by the RCMP, Crown or
Society other agencies. The offender must take responsibility for his or her actions and be
willing to participate voluntarily. The victim must be involved in one form or another to
jointly discuss the offence, how they have all been affected, and together develop a
plan to correct what has occurred. The coordinator follows up with an agreement and
makes sure that all the items stated in the contract are fulfilled. Ms. LaBoucane was
pleased to report an eighty percent success rate in reintegrating the offender into the
community as a productive member of society.

There are trained facilitators throughout Canada who run the well organized, RCMP
recognised, and strictly regulated restorative justice program. Although the North
Peace Justice Society is based in Fort St. John, Ms. LaBoucane has recently trained
three facilitators who will be providing the service in the Dawson Creek area as well.

As the society receives training funding only from the province, it is currently seeking
other funding to meet its yearly budget. Ms. LaBoucane advised that she would be
applying to the Peace River Regional District for financial support.

A question and answer period ensued.

The Chair thanked Ms. LaBoucane for the informative presentation on the society's
valuable service.

re: Activities in the Mr. Dahlin, Production Operations Manager introduced Frank Cook, of Operations and
Area Procurement, and went on to provide history leading to Shell Canada Ltd. acquiring the
Handout - Power Point mineral rights to approximately 300 sections of land in the Groundbirch area, through
Presentation land acquisition and purchase of the Duvernay Oil Corporation in 2008.

Lift from Table He explained that the company's current focus is on the Montney tight formation where
the nature of the rock makes it difficult to get gas to flow out of a well. This requires
more wells to be drilled per section of land and requires the use of hydraulic fracturing
(fracing). Currently the company has drilled over 150 wells from 40 wellsites / pads and
has 5 gas plants producing enough to heat 400,000 homes.

C-7 Mr. Dahlin discussed future plans to drill approximately 60 wells over the next year. The
August 6, 2010 - Shell plan is to drill multiple wells (up to 24) from larger well pads, with two well pads for
Canada Upstream - every three sections of land, and use horizontal drilling to reach up to two km from the
Groundbirch Sales Tap pad, and also construct a limited number of processing plants; thus reducing the
impacts that would otherwise result from smaller multiple area well sites. He referred to
traffic / road and water issues and of the need to engage with the local community
through public open houses which are being held throughout the area. They will be
initiating a Stakeholder Advisory Group early in October that will provide a forum to get
public input for the Integrated Impact Assessment process. They are also holding
another open house at the McLeod School on September 8, 2010 from 4 to 7 p.m.

In closing, Mr. Dahlin reiterated that Shell Canada Ltd. is planning to be for the long
term and is committed to transparency of its operations.
