Dr. Helm, Vice President of the Tumbler Ridge Museum Foundation began the presentation by expressing appreciation to the directors of the Peace River Regional District for the support they have provided in the past toward the establishment of the Peace Region Palaeontology Research Centre in Tumbler Ridge.
For the last seven years the centre has been sustained through unflagging fund-raising efforts of the volunteers, charitable organizations, and the Tumbler Ridge Museum Foundation. The District of Tumbler Ridge, as the backbone of support, has provided \$200,000 annually toward the operational expenses. This Grant-in-Aid, although much appreciated, does not cover all full-time salaries, development of exhibits, summer staff wages, field or research aspects, educational and tour programs or renovations.

The Tumbler Ridge Museum Foundation has aggressively and successfully applied to numerous federal, provincial, regional and private industry sources for annual funding toward capital projects. In May 2010 the expanded facility opened in the decommissioned elementary school and now occupies 25,000 square feet of space.

This has provided many opportunities to take this project to higher provincially, federally, and internationally recognized levels.

Lisa Buckley,
Palaeontologist

Richard McRae, Curator of Palaeontology provided a preliminary report on the excavation and BC's first complete dinosaur find which has occurred over the last three summers. The articulated portion of the dinosaur will be removed in 2011 and it is estimated to weigh between 2,000 to 4,500 kg. Another marine reptile specimen has been identified in the vicinity of Fort St. John with an estimated length of over 70 feet; surpassing the Royal Tyrell Museum's world record exhibit. Staff's systematic prospecting trips into the wilderness have revealed more dinosaur and marine reptile sites lying just beneath the surface of the land.

From a scientific point of view, this region's palaeontological resources are still virtually unexplored and priceless. The potential for an internationally recognized exhibition of these discoveries in Tumbler Ridge is achievable, but it will require long term funding commitments; establishment of an endowment fund; the support of the province and a formal designation of the Peace Regional Palaeontology Research Centre as a repository for BC's fossil heritage.

Dr. Helm closed by requesting further Regional District support toward bringing the goal of the purpose-built palaeontological museum potential into a viable and exciting reality, within the next five to ten years.
