PEACE RIVER REGIONAL DISTRICT**BYLAW NO. 2605, 2026**

A bylaw to specify fees and charges
for Seniors Aging in Place services

WHEREAS the Regional Board of the Peace River Regional District has adopted “Seniors Aging in Place Support Services Establishment Bylaw No. 2444, 2021”;

AND WHEREAS, the *Local Government Act* provides that the Regional Board may, by bylaw establish fees and charges for various Regional District services and Bylaw No. 2444, 2021 authorizes fees and charges as a method of cost recovery for the cost of providing the Seniors Aging in Place Support Services;

AND WHEREAS, the Regional Board wishes to increase user fees applicable to the Seniors Aging in Place Support Services to keep pace with increasing operational costs;

NOW THEREFORE, the Regional Board of the Peace River Regional District in open meeting assembled enacts as follows:

SECTION 1 – GENERAL PROVISIONS

1. This bylaw may be cited as “Seniors Aging in Place Services Fees and Charges Bylaw No. 2605, 2026.”
2. If any provision of this bylaw is declared to be illegal, invalid, or ultra vires, in whole or part, then that provision shall not apply and the remainder of this bylaw shall continue in full force and effect and be construed as if it had been enacted without the illegal, invalid, or ultra vires provision.
3. The headings used in this bylaw are for convenience only and do not form part of this bylaw, and are not to be used in the interpretation of this bylaw.
4. This bylaw shall take effect on June 1, 2026.
5. The fees and charges established in this Bylaw are applicable to meals, snow plowing and housekeeping services as provided through the authority of Seniors Aging in Place Support Services Establishment Bylaw No. 2444, 2021.
6. The fees and charges established in this Bylaw are exclusive of GST and PST, which will be added as applicable.
7. Schedule A - Seniors Aging in Place Support Services Fees, which sets out the fees that will be charged for Seniors Aging in Place Support Services is attached to and forms part of this bylaw.

SECTION 2 – AMENDMENTS TO MISCELLANEOUS FEES AND CHARGES BYLAW NO. 2483, 2022

8. Miscellaneous Fees and Charges Bylaw No. 2483, 2022 is amended as follows:
Section 2 – Fees and Charges, Part 4 is amended by deleting the words “Schedule D – Seniors Aging in Place Support Services Fees and Charges” and by replacing the words “Schedule E – Miscellaneous Application Fees” with the words “Schedule D – Miscellaneous Application Fees”
9. Schedule D - Seniors Aging in Place Support Services Fees and Charges attached to Miscellaneous Fees and Charges Bylaw No. 2483, 2022 is deleted in its entirety.

10. Schedule E – Miscellaneous Application Fees attached to Miscellaneous Fees and Charges Bylaw No. 2483, 2022 is renamed “Schedule D - Miscellaneous Application Fees.”
