PUBLIC NOTICE is hereby given to the electors of the Peace River Regional District that nominations will be received for the following offices for a four year term:

- One (1) Director representing Electoral Area B
- One (1) Director representing Electoral Area C
- One (1) Director representing Electoral Area D
- One (1) Director representing Electoral Area E

Nominations will be received by the Chief Election Officer, or designate, from **9:00 am, September 1, 2026**, until not later than **4:00 pm, September 11, 2026**, as follows:

QUALIFICATIONS FOR OFFICE

A person is qualified to be nominated, elected, and to hold office as a member of local government if they meet the following criteria:

- Canadian citizen;
- 18 years of age or older on general voting day, October 17, 2026;
- resident of British Columbia for at least six (6) months immediately before the day nomination papers are filed; and
- not disqualified by the *Local Government Act* or any other enactment from being nominated for, being elected to or holding the office, or be otherwise disqualified by law.

CAMPAIGN PERIOD EXPENSE LIMITS

In accordance with the *Local Elections Campaign Financing Act*, for the 2026 general local election, the expense limit for electoral area director candidates during the campaign period is **\$6,161.89**.

THIRD PARTY ADVERTISING LIMITS

In accordance with the *Local Elections Campaign Financing Act*, for the 2026 general local elections, the third party directed advertising limit is **\$924.28**.
