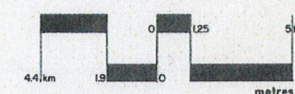

Official Zoning Map

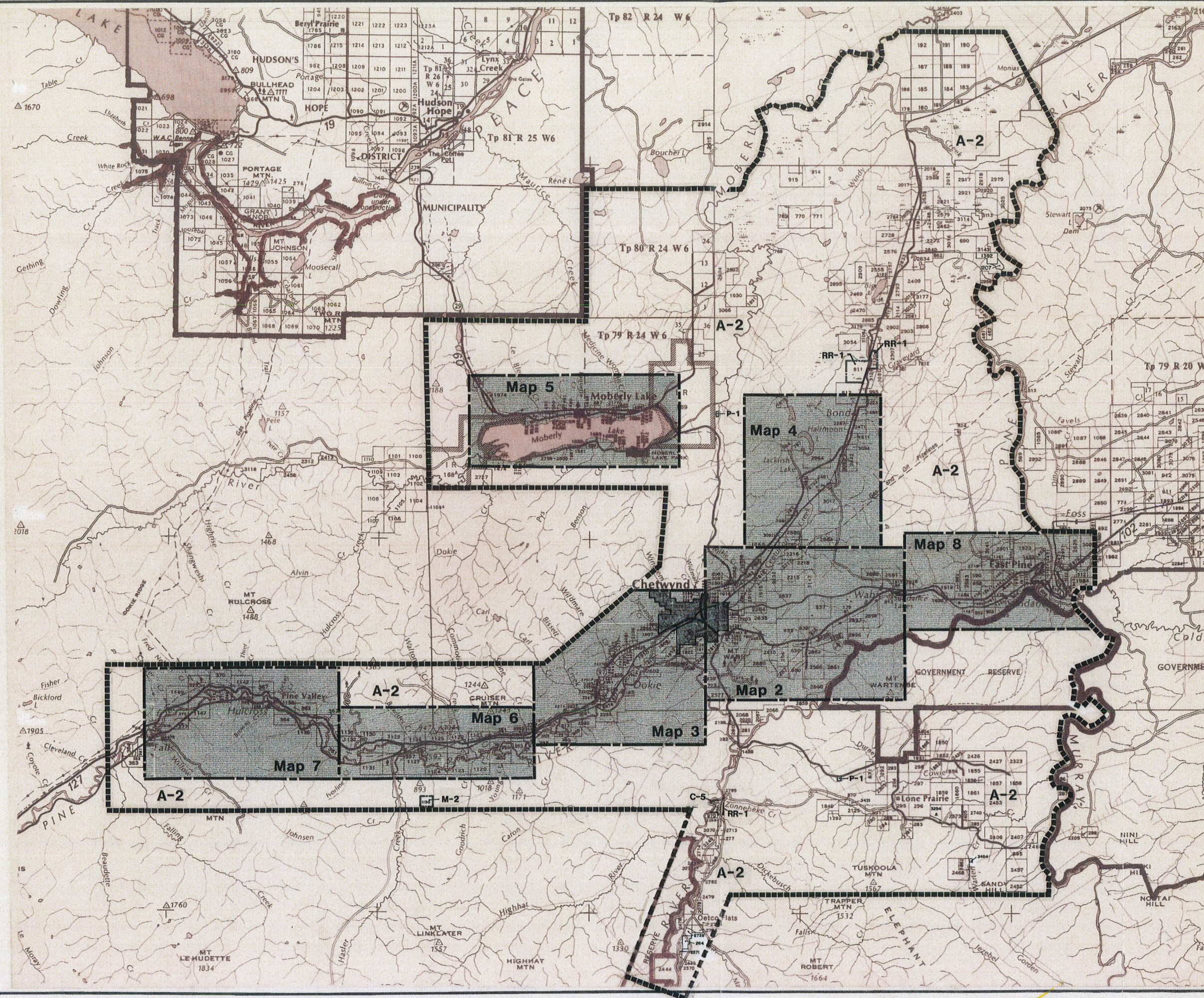

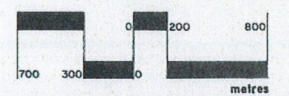

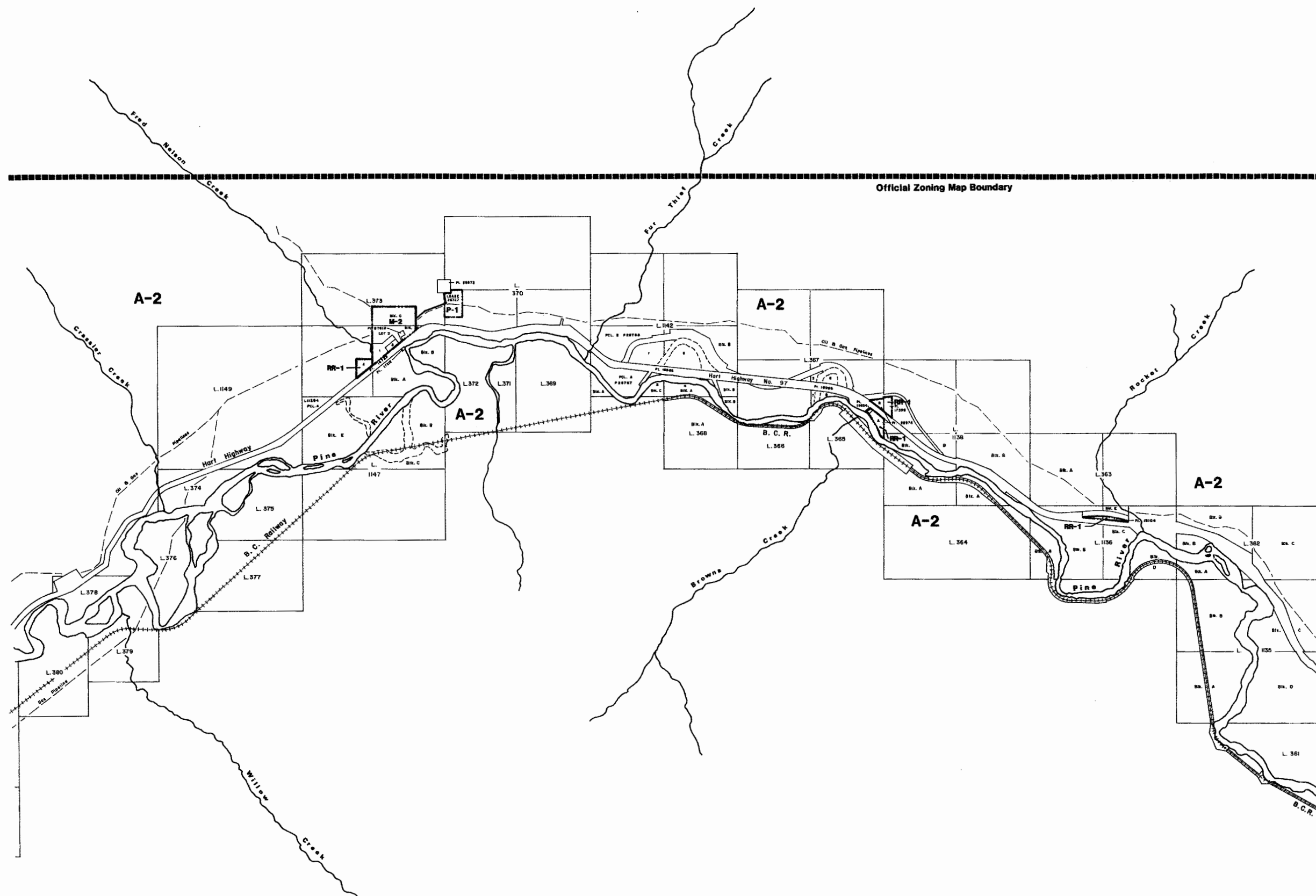

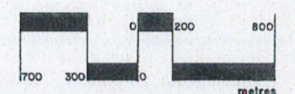
