

PEACE RIVER REGIONAL DISTRICT
Bylaw No. 2492, 2022

*A bylaw to amend 'Chilton Subdivision Sewage
Collection Service Area Establishment Bylaw No.
1328, 2000'.*

WHEREAS, the Peace River Regional District established a service through adoption of 'Chilton Subdivision Sewage Collection Service Area Establishment Bylaw No. 1328, 2000', to authorize the collection of sewage from the Chilton Subdivision; and

WHEREAS, the Peace River Regional District wishes to amend the service by increasing the maximum requisition, and adding the authority to impose user fees as a method of cost recovery; and

WHEREAS the *Local Government Act* allows for the amendment of a service establishment bylaw so long as the requirements of the legislation are met, and the Peace River Regional District has met those requirements, including obtaining written consent from the participating areas and approval from the Inspector of Municipalities;

NOW THEREFORE, the Board of the Peace River Regional District in open meeting assembled, enacts as follows:

ADMINISTRATIVE PROVISIONS

1. This bylaw may be cited as "Chilton Subdivision Sewage Collection Service Area Establishment Amendment Bylaw No. 2492, 2022".
2. If any portion of this bylaw is declared invalid by a court, the invalid portion shall be severed and the remainder of the bylaw is deemed valid.
3. The headings used in this bylaw are for convenience only and do not form part of this bylaw, and are not to be used in the interpretation of this bylaw.

AMENDMENTS

4. Chilton Subdivision Sewage Collection Service Area Establishment Bylaw No. 1328, 2000 is hereby amended as follows:

Preamble

- a. Paragraph one of the preamble is amended by deleting the words "Section 796 of".
- b. Paragraph three of the preamble is amended by deleting the words "Section 797.4 of" and the words "Section 632 of".
- c. Paragraph four of the preamble is amended by deleting the words "Section 801.5 of".
- d. Paragraph five of the preamble is amended by deleting the words "Section 801.5(2) of".

- e. Paragraph six of the preamble is amended by deleting the words "Section 801 of".
- f. **Part 1** 'Service Being Established' is amended by deleting the words "to provide".
- g. **Part 3** under the title 'Participating Areas' is amended by striking the words "the defined portion of" and the words "as shown on the map attached as Schedule A to this by-law".
- h. **Part 4** under the title 'Cost Recovery', shall be deleted in its entirety and replaced with a new Part 4 which reads as follows:


 "4. The annual cost of providing the Service within the service area boundary as defined in Part 2 – Service Area Boundaries, and shown on Schedule A, shall be recovered by one of more of the following:
 - a) A parcel tax imposed pursuant to the provisions of the *Local Government Act*;
 - b) Fees and charges imposed pursuant to the provisions of the *Local Government Act*;
 - c) Revenues raised by other means authorized by the *Local Government Act*, or another Act;
 - d) Revenues raised by way of agreement, enterprise, gift, grant, or otherwise."
- i. **Part 5** under the title 'Requisition' is amended by deleting the words "under Section 4", and deleting the word "provided", and by replacing "\$35,000" with "\$100,000".

READ A SECOND TIME this 8th day of September, 2022.

READ A THIRD TIME this 8th day of September, 2022.
