**Bylaw No. 1360, 2001**

A bylaw to convert the function of Charlie Lake Fire  
Protection Specified Area to a Service Area and amend its  
boundaries

WHEREAS the Board of the Peace River Regional District adopted Charlie Lake Fire Protection Specified Area Establishment Bylaw No. 267, 1980;

AND WHEREAS under the *Local Government Act*, a Regional District exercising a power to provide a service other than a general service, may adopt a bylaw respecting that service which:

- a) meets the requirements of the *Local Government Act* for an establishing bylaw;
- b) is adopted in accordance with the requirements of *Local Government Act* as if it were a bylaw amending an establishing bylaw;

AND WHEREAS the Board of the Peace River Regional District wishes to convert the Charlie Lake Fire Protection Specified Area to a service area and amend its boundaries;

NOW THEREFORE the Board of the Peace River Regional District, in open meeting assembled, enacts as follows:

**SERVICE BEING ESTABLISHED**

1. The Charlie Lake Fire Protection Specified Area created under Bylaw No. 267 is hereby established as the Charlie Lake Fire Protection Specified Area.

**SERVICE AREA BOUNDARIES**

2. The service area boundary for the Charlie Lake Fire Protection Service Area is a defined portion of Electoral Areas 'C' and 'B', as shown outlined in a heavy black line on Schedule 'A' – Charlie Lake Rural Fire Protection Service Area Boundary, which is attached to and forms part of this bylaw.

**PARTICIPATING AREA**

- 2A. The participating area for the service is a defined portion of Electoral Area 'C' and 'B' as shown on Schedule 'A' – Charlie Lake Rural Fire Protection Service Area Boundary, which is attached to and forms part of this bylaw.

**COST RECOVERY**

3. The annual cost of providing Charlie Lake Fire Protection within the service area boundary as defined in Section 2, shall be recovered by one of the following:
  - A property value tax imposed pursuant to the provisions of the *Local Government Act*, levied against the net taxable value of improvements only
  - Revenues raised by other means authorized by the *Local Government Act*, or another Act
  - Revenues raised by way of agreement, enterprise, gift, grant, or otherwise.

**MAXIMUM REQUISITION**

4. The maximum requisition limit that may be requisitioned in any one year for the service is the greater of \$1,422,578 or an amount equal to the amount that could be raised by a property value tax of \$1.57/\$1,000 when applied to the next taxable value of land and improvements in the service area.

**CITATION**

5. This bylaw may be cited as "Charlie Lake Fire Protection Service Area Establishment Bylaw No. 1360, 2001".
