**BY-LAW NO. 1066, 1996**

**A by-law to establish a Local Service to provide  
a Sewage Collection, Conveyance, Treatment and Disposal  
System within Electoral Area "D".**

**WHEREAS the Regional Board of the Peace River Regional District (the Regional Board) may, by by-law, establish and operate a Local Service under the provisions of Section 788 of the Municipal Act;**

**AND WHEREAS the Board wishes to establish a Local Service for the purpose of providing a Sewage Collection, Conveyance, Treatment and Disposal System for the benefit of the residents of the Local Service Area;**

**AND WHEREAS the Board has received a petition requesting the installation of a Sewage System in Electoral Area "D", and such petition has been determined to be sufficient pursuant to Sections 801 and 659 of the Municipal Act;**

**AND WHEREAS the Regional Board waives the assent requirement of Section 795(2)(a)(i) pursuant to Section 800(1)(a) of the Municipal Act;**

**AND WHEREAS the Director of Electoral Area "D" has consented, in writing, to the adoption of the By-law;**

**AND WHEREAS the approval of the Inspector of Municipalities is required under Section 795(1)(a) of the Municipal Act;**

**NOW THEREFORE the Board of the Peace River Regional District, in open meeting assembled, enacts as follows:**

**Service being established**

1. The Local Service hereby established under this by-law and to be operated is the collection, conveyance, treatment and disposal of sewage for the benefit of the residents of the local service area, hereinafter known as the "Kelly Lake Sewage Local Service Area".

**Service Area Boundaries**

2. The Local Service Area is contained within the boundary shown on the plan annexed hereto as Schedule "A".

**Participating Area**

3. The only participant in the local service established under Section 1 is the defined portion of Electoral Area "D" as described in Schedule "A".

**Cost Recovery**

4. The annual operating and debt servicing costs for the service area shall be recovered by one or more of the following:
  - a) imposition of fees and other charges; and
  - b) requisition under Section 809.1 of the Municipal Act to be collected by a parcel tax in the Local Service Area, to be levied and collected under Section 810.1(2).
  - c) requisition under Section 809.1 of the Municipal Act to be collected by a property value tax in the Local Service Area, to be levied and collected under Section 810.1(1) on land and improvements.

Limit on Annual Operating Expenses

5. The maximum amount that may be raised by requisition under Section 4, exclusive of debt servicing, for the service provided under Section 1 is \$18,750. [Bylaw No. 1885, 2010]

6. This by-law may be cited as "Kelly Lake Sewage Local Service Area Establishment By-law No. 1066, 1996".
