## PEACE RIVER REGIONAL DISTRICT Bylaw No. 2194, 2015

A Bylaw to amend Charlie Lake Sewage Local Service Area Establishment Bylaw No. 678, 1990

WHEREAS "Charlie Lake Sewage Local Service Area Establishment Bylaw No. 678, 1990", was adopted by the Peace River Regional District Board on July 31, 1990;

AND WHEREAS the Board deems it appropriate and necessary to amend Bylaw No. 678, 1990;

AND WHEREAS the written consent of at least 2/3 of the participants of the service has been obtained pursuant to section 802 of the *Local Government Act*;

NOW THEREFORE the Regional Board of the Peace River Regional District, in open meeting assembled, enacts as follows:

#### 1. Citation

This by-law may be cited for all purposes as "Charlie Lake Sewage Local Service Area Establishment Amendment Bylaw No. 2194, 2015".

### 2. Enactments

- (a) That Charlie Lake Sewage Local Service Area Establishment By-law No. 678, 1990 be amended by deleting Schedule A and replacing it with the attached Schedule 'A' which forms part of this bylaw.
- (b) That Charlie Lake Sewage Local Service Area Establishment By-law No. 678, 1990 be amended by deleting section 3 (Cost Recovery) in its entirety and replacing with the following:

## "Cost Recovery

- 3. The operating, capital and debt servicing cost of providing the Service shall be recovered by one or more of the following:
- (a) imposition of fees and other charges;
- (b) parcel taxes imposed in accordance with Division 4.3 of the Local Government Act:
- (c) revenues raised by way of agreement, enterprise, gift, grant or otherwise; and,
- (d) revenues raised by other means authorized by the Local Government Act or another Act."
