

**PEACE RIVER REGIONAL DISTRICT
BYLAW NO. 2560, 2024**

A bylaw to amend "Dawson Creek Fringe Area
Sewer System User Fees Bylaw No. 2519, 2023"

WHEREAS the Regional Board of the Peace River Regional District has adopted "Dawson Creek Fringe Area Sewer Systems User Fees Bylaw No. 2519, 2023";

AND WHEREAS, the Regional Board wishes to amend Bylaw 2519, 2023 to update the fees imposed by that bylaw;

NOW, THEREFORE, the Regional Board of the Peace River Regional District, in open meeting assembled, enacts as follows:

GENERAL PROVISIONS

1. This bylaw may be cited as "Dawson Creek Fringe Area Sewer Systems User Fee Amendment Bylaw No. 2560, 2024."
2. If any portion of this bylaw is declared invalid by a court, the invalid portion shall be severed, and the remainder of the bylaw is deemed valid.
3. The headings used in this bylaw are for convenience only, do not form part of this bylaw, and are not to be used in interpreting this bylaw.


AMENDMENT

4. "Dawson Creek Fringe Area Sewer System User Fees Bylaw No. 2519, 2023" is amended by replacing Schedule 'A' to Bylaw No. 2519 with the attached 'Schedule A Sewer System User Fees and Charges, 2025-2028'.


